Noteworthy

- •69% of the parish budget (\$850K) supports St. Teresa Elementary School and Pius X High School
- •\$319K were made in building improvements to the school.
- •Tithing was \$1,062,696 which was \$76K **less** than the previous year.
- •Endowment income was \$158,528—up \$21K from the previous year.
- •Joy of the Gospel rebates were \$44,344. The collections from this 2014 campaign are coming to an end.
- •An anonymous donor has donated \$100-150K annually but in Fall 2018, we were made aware that this would not continue.
- •Technology Infrastructure and Support previously donated will now be assessed directly to parish schools (about \$75K per year).
- •Reduction of Parish support transferred to school: \$238K is off-set by increases in tuition and collection of Good Shepherd Scholarships. Tuition, scholarships, and fees fund approximately 29% of school costs, versus 7% in the previous year.
- •2019-20 St. Teresa School cost per student is about \$4,900. Lincoln Public Schools' cost per student for the same year is budgeted at \$10,826.

Paycheck Protection Program

We are a community in service of one another *and* we are an employer. In Spring of 2020, our parish received \$243,400 in funding from the SBA Paycheck Protection Program related to COVID-19. Several Lincoln parishes received similar funding. This loan is designed to be forgivable and as such, these funds have been documented and deployed for eligible expenses which include payroll and utilities. We anticipate full forgiveness of this SBA loan. While extremely grateful for these funds which enabled the parish and school to cover payroll expenses during uncertain times and which, in effect, temporarily filled a sizable operational gap in our budget, we are also fully aware that this was one-time assistance, whereas the effects of the pandemic have proved to be ongoing.
